The Wisconsin Department of Natural Resources (Department) received the *Revised Work Plan for DERF Investigation Activities* for the above-referenced site on July 9, 2007. The Department reviewed the work plan and noticed that item #1 in my June 4, 2007 letter was not addressed. The discrepancy was brought to the attention of your consultant. Sigma submitted an amended scope of work and cost estimate via email that removed monitoring wells SMW-1, SMW-2 and SMW-5 from the quarterly monitoring plan. The Department approves the revised, amended scope of work for the site investigation.

Cost approved for the site investigation scope of work is \$28,468. The total cost approved to date for this site is \$28,468.

Please be aware that you are required to comply with <u>all</u> applicable statutes and administrative rules including the NR 700 series, Wisconsin Administrative Code, hazardous waste management and wastewater discharges. Also, please be aware that this letter does not represent Department "certification" that any response actions taken at your property, such as site investigation, remedial action or case closure under the ch. NR 700 series, are "approved by the Department," as those terms are used in the "remediated property; purchaser liability" section of the hazardous substance discharge law, s. 292.11, Stats.

This approval does not guarantee the reimbursement of costs under the Dry Cleaner Environmental Response Program. Final determination regarding the eligibility of costs for reimbursement will be made at the time of claim review. Brenda,

As requested, attached are the revised cost for the proposed DERF Site Investigation activities at the Master Dry Cleaning property. My previous e-mail included revised costs for the laboratory analysis of the quarterly groundwater samples. However, the revised cost estimate did not account for the decrease in labor hours and associated equipment expenses for sampling less wells (7 wells instead of 10 wells). Therefore the estimated investigation cost has been revised to account for the decrease in field personnel sampling time, equipment costs, and laboratory expenses. The estimate cost is approximately \$28,468. The revised cost estimate is included for your review.
