Dear Mr. Kler:

The Wisconsin Department of Natural Resources (DNR) has received a request from SCS Engineers dated June 24, 2020, to turn-off the Soil Vapor Extraction (SVE) system and remove it from your site located at 9922 West Capital Drive, Milwaukee, Wisconsin. The DNR cannot approve the shut down and removal of this system at this time based on the following:

- On August 12, 2018, the DNR's letter approved the installation of soil extraction wells and the use of existing groundwater monitoring wells on the north side of your property to reduce residual soil contamination and improve groundwater quality in this area.
- The DNR approved costs to run this system for a maximum of six (6) months as proposed in the document dated September 2016 titled, *"Revised Remedial Action Options Plan and Remedial Design Report PSK Investments and Grace Christian Fellowship Properties 9922 & 9900 West Capitol Drive Milwaukee, Wisconsin"*
- After shutting the SVE system down for 2-months, the DNR's approval (August 12, 2018) required groundwater testing be conducted to determine whether there has been any significant effect.
- The SVE system has only been in operation since April 9, 2020, almost three months out of the six-month approval to run the system. Based on the SVE system start-up, the system is required to be run until October 2020 at which point the system is required to be shut down for 2-quarters and then groundwater sampling for effectiveness.

Please review the August 14, 2018 letter from the DNR pertaining to the above. The DNR will consider your request for shut down of the system and removal after submittal of a report on this activity.
