I have completed the audit of your application for reimbursement from the Dry Cleaner Environmental Response Fund (DERF) Program. Following is a summary of your audited expenses:

After working with your consultant, there were no ineligible expenses claimed in this reimbursement request.

Your total eligible expenses for this site are 36,973.42. There is a 10,000.00 deductible that covers your first 200,000.00 worth of eligible expenses. The values of the deductibles are all established in the WI State Statue section 292.65 (8)(e).

Under normal circumstances, your reimbursement check for \$26,973.42 would be mailed to you shortly after receiving this letter. However, a decrease in the number of active, licensed dry cleaners in the state means that revenues in the Dry Cleaner Fund are insufficient to pay current claims. As a result, I am unable to send reimbursement until there are sufficient revenues in the account. I will be keeping a careful eye on incoming revenue and the fund balance, and as soon as funds are available, eligible claims will be paid on a first-come, first-served basis. I regret that I am unable to predict the length of the delay of your reimbursement at this time, but I do believe it will be spring or summer of 2009.
