Table 11 in the February 2017 Site Investigation and Preliminary Remedial Action Identification Report updated in the July 2, 2019 Request for Status Update letter included a list of wells recommended for quarterly, semiannual and annual monitoring. The Village of Grafton is requesting flexibility for the quarterly/semiannual/annual sampling requirements for private water wells if exterior spigots are not functional during the pandemic.

4. Include the reasoning/rationale for the request and related to the COVID19 emergency (1 paragraph summary on why the COVID19 emergency justifies the assistance sought and what actions the requestor took prior to the request to meet the requirement).

During the annual sampling event completed between March 30 and April 2, 2020, well PW1716LR located at the Watts Residence at 1716 Lakeview Road was not sampled. Well PW1716LR could not be sampled during the March / April 2020 annual sampling event because interior access to the residence by sampling personnel was prohibited due to the global pandemic. Exterior spigots were not yet functional after the winter months. The Village requests flexibility with sampling requirements if exterior spigots are not functional for private water wells to avoid interior access to private residences during the pandemic. Include bulleted points of what measures will be taken to mitigate/minimize the potential environmental impacts (if any).

Well PW1716LR will be sampled during the 2<sup>nd</sup> Quarter sampling event likely occurring during May 2020 assuming exterior spigots are turned on. Any residences with functional exterior spigots will be sampled according to the sampling requirements.

5. Specify the specific time period that the request is for including the rationale.

This request extends throughout this pandemic. Annual reporting will occur as required summarizing the results of all samples able to be collected.

John, I heard from your voicemail that you are working from home. I wanted to inform you that the Village of Grafton has hired TRC to complete the Grafton Lime Kiln Landfill groundwater monitoring work for 2020. Currently TRC is gathering historic information from AECOM and planning for 1Q sampling early next week. We do have concerns at this point about the ability to test some of the private wells if they are not able to be sampled from outside. We have a current Village mandate to not enter residences unless it is an emergency.

Does the DNR have any current guidance on how to proceed with private well sampling?

In the near future it might be good to set up a phone conference to make sure we have the right directives and know the order of importance as far as the new vapor intrusion requirements.
