UPDATED FACT SHEET: Environmental Remediation at the Former Shorewood Queensway Cleaners June 17, 2020

What: Soil Excavation and Chemical Treatment, landfill disposal, backfill, grading, revegetation

Where: NE Corner of N Oakland and E. Marion Street (4300 N. Oakland and adjacent 1808 E. Marion Street Parcels)

Why: Removal of soil containing dry-cleaning solvent from historic operation of dry cleaner 1960 to 2017

When: July 8 to August 7, Establish of vegetation and watering to continue longer. Groundwater monitoring into 2021

### **Permits and Approvals**

- 1. WDNR Approved Remedial Action Plan and Use of Soil Mixing Process
- 2. Shorewood Planning Review and Demolition Permit
- 3. Landfill Approval to Accept Soil, Concrete

#### Description

- Temporary 6' high Chain Link Fence COMPLETE
- Concrete and asphalt breaking and removal Partially complete west areas
- Contaminated soil excavation and removal Partially complete west areas
- Dump truck traffic removal of concrete and soil, placement of clean backfill. Partially complete
- Addition of liquid and solid amendments to the soil (Fenton's Reagent and BAM<sup>TM</sup>) Weeks of July 13 and 20
- Temporary placement of treated soil in eight 30 cubic yard drop boxes for short-term storage. Boxes to be
  covered and labeled with warning signs. Emptied with hauling soil to the landfill when laboratory results
  indicate soil can be accepted July 13 to August 7
- Clean backfill replacement, compaction in lifts, using vibrating rolling compactor Weeks July 13, 20, 27
- Clean topsoil at surface Week July 27 or August 3
- Establish grass vegetation and shrub plantings along Oakland –August to September 2020

### **Health and Safety**

- Limit site access with fencing
- No Parking North side of Marion Street adjacent to the Property
- Standard worker safety equipment (steel toe shoes, hard hat, reflective vest, plus protective gloves). Possible short term use of respirator / face shield and Tyvek suits when actively spraying chemicals to soil.
- When Excavating / Mixing Soils: Twice daily evaluations of breathing space vapors at four perimeter work zone locations using field meters, with comparison to workplace exposure standards for chemicals of concern
- Contingency Action Plans if elevated vapor readings at perimeter of work zone, temporarily cease operations.
   Re-assess readings. Take mitigating actions as appropriate and necessary, (blower / adjust storage box covers) and evaluate if need to modify operations until conditions change (wind, other factors).

Weekly updates on progress, monitoring data provided to Village on Report Form during active treatment phase
