Sorry for the delay. On the certification statement issue this is what I can tell you. I have over 34 years of experience in the field and could sign and certify as a Scientist. We also have someone on staff that is a licensed Engineer in Wisconsin that could sign and certify the response under that designation. If the response letter requires a hydrogeologist/geologist then we have one person on staff (Nick Hill) that has submitted their paperwork for this designation but does not currently have Wisco approval. With Wayne Fassbender's retirement we are scrambling to get this approval and looking to hire in Wisconsin.

With regard to your questions regarding waste management at the Martino's Dry Cleaner, here is what I can tell you:

1. Martino's no longer uses Perc (PCE). All Perc was removed from the premises more than two years ago.
2. Martino's removed the PCE machine around 2020 and currently uses DF 2000 Hydrocarbon solvent.
3. Waste was being picked up by DLD until recently. Martino's now uses Safety Kleen.
4. Martino's uses a Union, 60lb. dry to dry machine.
5. Waste is removed from the machine and stored on site until picked up by Safety Kleen.
