I am writing to confirm our telephone call of April 27, 2022. During the call I informed you that Travelers has searched for policies issued to either Kramer's Cleaning Center or Imogene's Cleaning Center and has found no record of any primary-level general liability or umbrella policies. Travelers has initiated a search for the policy referenced in the letter dated March 16, 2022 from Josie Schultz. As I informed you the alleged policy number TUB954034-71 indicates that this policy, if issued, would only provide coverage for Workers Compensation.

If the search for the alleged Workers Compensation policy provides any results that are applicable to the claim from the WDNR relating to historic dry-cleaning contamination we will forward that information.
