When I purchased the business in 1987 the dry cleaning machine was a Martin Transfer machine. In the 1960s and 70s the had a number of self-serve dry cleaning machines which I understand were notorious for overfilling and solvent spills occurred often.

By 1987 when I purchased the business all the self-serve machines were gone and by 1990 I remodeled the whole store and replaced the Transfer DC machine with a new Dry to Dry D.C. machine. That machine was replaced in 2010 with a newer Generation Dry Cleaning machine. So I am confident in saying that since 1990 there has no more discharges into the environment..

Mr Dequaine is planning on operating as a partial dry store taking most clothing items to his other plant. The only use for our dry cleaning machine would be for quick turn around items and special order items like drapery, school band or choral uniforms that wouldn't be feasible to transport.
