Your proposed change order is approved. You may proceed with the proposed work. The DNR received the proposal titled "Revised Additional Budget Request" prepared by KPRG and Associates, Inc. and submitted on your behalf on July 7, 2011.

The proposal includes the installation of 8 soil borings and collection of up to 16 soil samples which will be analyzed for volatile organic compounds (VOCs). The proposal also includes installation of a second sub-slab vapor probe and collection and analysis of vapor samples from both vapor probes. A Site Investigation Report Addendum will also be prepared.

Cost approved for this change order (#1) is \$3,955 for consulting labor and expenses and \$3,150 for sub-contractors, for a total of \$7,105. The total cost approved to date for this site is \$22,120 (approved 6/23/09) + \$7,105 (approved in this letter) = \$29,225 (total).

Please be aware that you are required to comply with <u>all</u> applicable statutes and administrative rules including the NR 700 series, Wisconsin Administrative Code, hazardous waste management and wastewater discharges.
