Hi Don,

Nice talking to you and Scott today! As discussed, the following revisions need to be made prior to me finalizing the Remedial Action Bid approval letter:

- The applicant, Chris Dockery as the DERF agent, needs to sign the Remedial Action Bid Proposals Summary (Form 4400-212).
- Please provide justification why a pilot test is not going to be conducted prior to full implementation of the remedy.
- Two soil borings need to be installed with two unsaturated samples collected. These should be located north of MW-2 and northeast of MW-2 to define the extent of contamination in unsaturated soil.
- One monitoring well should be installed at the location northeast of MW-2 to define the extent of groundwater contamination because groundwater flow shows variation between the east and northeast.
- The piezometer PZ-1 isn't useful for defining vertical extent due to the significant distance from the source area. A piezometer should be installed closer to the source area, east-adjacent to the building in the downgradient direction. It is preferred that it is nested with an existing water table well.
- The potable well PW-4 should be sampled again post-remedy to ensure it remains clean.
- Since the chlorinated compounds are still in use at the site, there is no need to sample indoor air.
- In order to show a vapor mitigation system can be shut off permanently, the system should be shut off for approximately one month prior to the first sub-slab vapor sampling round. If the first sample is below the vapor risk screening levels (VRSLs), the mitigation system should remain off. 1-2 additional sub-slab vapor sampling rounds (with at least one sample collected during the winter months/heating season) needs to be collected and the results must be below the VRSLs to show the system can remain off permanently.
- The additional costs for the above revisions need to be submitted with the revised remedial action bid proposal.

It is recommended the site investigation (SI) work be conducted prior to the remedy to ensure that no modifications are needed to the remedy if additional contamination were found. The SI results can be communicated to me via email. Then the full summary of the SI work can be included in the first report after the remedy has been implemented.

Hey Guys,

Based on our discussion earlier about Smoke Out Cleaners, you guys suggested I should contact Jennifer. I talked to Jennifer and she gave two options to address this; however, she recommends option one as the preferred method:

- Send email to DERF applicant and consultant to provide a scope of work for the additional investigation (two soil borings, one monitoring well, one piezometer, as discussed) with the detailed cost summary sheet. Once I receive that I can incorporate those costs into the remedial action bid approval letter. The costs would get rolled in with the remedial action costs instead of them being site investigation costs. The remedial design report that they submit would then include the remedy and additional SI work proposed.
- 2) Provide the remedial action bid approval letter with the additional investigation conditions outlined in the letter. They would then send in a combined remedial design report and scope of work for the additional investigation with the detailed cost summary sheet. I would then have to provide a remedial action change order approval letter for the additional costs (again, the costs would get rolled in with the remedial action costs instead of SI costs).

Therefore, I plan to go with Option 1, so I will contact the DERF applicant and consultant to verbally talk through the additional SI actions needed, then follow up with an email documenting those actions needed.
