On June 26, 2009, the Wisconsin Department of Natural Resources (Department) received your request to hire Terracon as your environmental consultant for the Site Investigation activities at the Dry Cleaners Etc site. After careful review of the submitted proposals the Department is approving your request to hire Terracon for the Site Investigation activities at the Dry Cleaners Etc site. The Scope of Work for the Site Investigation (Stage 1) is also approved.

The Scope of Work for the Site Investigation consists of two stages. Stage 1 will consist of assessing the soil and groundwater and analyzing the results to determine if further investigation is needed. A Stage 1 investigation report will be submitted to the Department and the Department will determine whether or not to proceed with Stage 2. The Total Cost approved for this scope of work (Stage 1 and Stage 2) is \$34,244.50.


