Kristin,

We've been discussing the project and payment situation with Jim, and we are making some progress. I still have a hurdle or two on my end - my boss isn't thrilled with getting paid far below our standard billing rates, and waiting months for payment, but I'm working on trying to get him to agree to do the work because I want to help move this project along.

Before the budget and costs get finalized, I have reviewed the scope of work from 2012, and just want to verify with you that the scope and your expectations haven't changed:

Scope

The scope is shown on the attached map that has all the site data so far, proposed borings, and proposed depths of soil samples, water screened intervals, and grab soil vapor samples around the utilities.

Basically:

- Five geoprobe borings, two soils samples per boring for VOCs.
- Three completed as NR 141 monitoring wells for GW sampling
- Two completed with 1" wells, for one round of grab GW sampling for VOCs, and one grab soil vapor sample for CVOCs
- Two rounds of GW sampling from the three new wells and the four existing wells / piezo for VOCs. That will give us 4 rounds from four locations, and two rounds from three new wells.
- Get Methane, ethane, ethene, and other parameters from GW from the three new wells-I
 could skip this if you aren't set on it not that helpful or necessary
- Drum disposal
- Data Evaluation, Interpretation, Report

Not Needed:

• Indoor subslab vapor sample - have task for this with \$595 budget, but not including it in the total, as an active dry cleaner, so not needed.

Budget

Budget with the previous 2012 Change Order approved would be \$31,572.50 (not counting the subslab vapor task).

Spent and claimed is \$16,051.50, leaving a working budget of \$15,521.

In looking this over, with the planned hours and scope, it will be really difficult to get this work done for that amount of money.

I know Jim has a limited amount of funds, so I'd like to add another \$1,000 to the SI report budget in the change order, bringing the future budget up to \$16,521.

Even at that amount, it will be tough to get this done, but we will do our best.

<u>Outcome</u>

At the end of this phase, we hope to have the SI report completed, with WDNR approval that the

investigation is done. Of course, if the data doesn't cooperate, more work might be needed, but can you look over the proposed scope and budget, and think through if the results come back reasonably clean at the new boring locations, would you be comfortable signing off that the SI is done?

If you will require more drilling or groundwater sampling regardless of what these next results demonstrate, please let us know now, so that doesn't come as a surprise down the road.

Once I hear back from you, I'll update the Change Order and work on getting my boss to OK the work to proceed - for \$16,521.
