Mr. Matt Dahlem of Fehr Graham submitted a Dry Cleaner Environmental Response Program (DERP) change order request and site investigation workplan to the Department of Natural Resources (DNR) on your behalf on August 23, 2021. Your proposed Change Order #4 is approved, and you may proceed with the proposed work.

The proposed work plan includes groundwater sampling, installation and sampling of sub-slab vapor ports, and a sanitary sewer vapor investigation.
