Hi Dillon,

Thanks for the conversation this afternoon to discuss the recent status update that was submitted for Tidy Cleaners.

Sanitary sewer gas did not exceed 10% of the sanitary sewer gas screening levels (SSGSLs), however there is concerns with the on-site building cleanout detecting PCE greater than the vapor action level (VAL). Because this is an active dry cleaner, this won't need further investigation at this time, however we may require the P-trap/seal(s) be maintained as a continuing obligation at time of closure.

There are concerns with the current monitoring wells consistently detecting PCE above the enforcement standard, and I can't see us getting away with not further delineating off-site to the south and east at a minimum. There should also be an evaluation of the utility backfill potentially acting as a preferential pathway for contamination to move, and consider whether a monitoring well needs to be screened within the backfill.

Also to consider is that when subsurface vapors are at or over vapor risk screening levels, then Wis. Admin. Code §§ NR 722.09 and 726.05 require remedial action to reduce the mass and concentration of the vapor source. Because there are VRSL exceedances at the on-site building, a remediation needs to be completed to address the source of vapors, and I recommend submitting an RAOR for review.
