Dear Mr. Linskens:

In accordance with s. 292.81(4), Wis. Stats., you are hereby notified that the Department of Natural Resources ("Department") intends to file a lien against the above-referenced property in order to recover costs incurred by the Department related to investigation of chlorinated volatile organic compound (CVOC) contamination associated with the property.

As of the date of this letter we estimate that the Department has incurred costs in the amount of \$32,306.12 (thirty-two thousand, three hundred six dollars and twelve cents). The Department may incur additional costs for investigation or cleanup activities at the site.

The lien will be filed on or after Friday, August 11, 2017. This provides you with a minimum of 60 days notice before the Department files the lien.

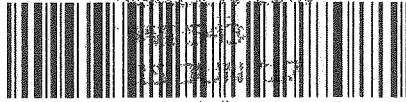
