In accordance with s. 292.81(4), Wis. Stats., you are hereby notified that the Department of Natural Resources ("Department') intends to file a lien against the above-referenced property in order to recover costs incurred by the Department related to investigation of chlorinated volatile organic compound (CVOC) contamination associated with the property.
