In accordance with Wis. Stats. s. 292.81(2), you are hereby notified that the Wisconsin Department of Natural Resources (the "Department") is in the process of hiring a contractor to complete the following tasks and associated actions for your property at 513 Grand Avenue in Little Chute, Wisconsin, parcel number 260045700:

1. Locate, inspect and sample three groundwater monitoring wells with analysis for volatile organic compounds (VOCs);
2. Write an Interim Action Report in accordance with Wis. Adm. Code s. NR 708.15 that documents actions performed by the United States Environmental Protection Agency (USEPA);
3. Write a Site Investigation Report in accordance with Wis. Adm. Code s. NR 716.15 that compiles and documents actions performed by the Department, the Department of Health Services (DHS) and USEPA, including recommendations for additional investigation activities;

This contractor will be hired unless you act by November 1, 2018 to hire a qualified contractor to properly do the work described in this paragraph.

This letter is also to notify you that you could be held responsible for reimbursing the Department for expenses that the Department incurs to do the work described in this letter and that the Department may file a lien against the above-described property to recover the expenses that it incurs, including staff costs and related expenses to oversee the work. Please note that this site is currently in the Dry Cleaner Environmental Response Program (DERP) and expenses eligible for reimbursement at this site under DERP may be excluded from cost recovery.
