Dear Ms. Smith:

On September 15, 2023, the Department of Natural Resources (DNR) received a *Limited Phase II Environmental Site Assessment for Vapor Intrusion*, dated September 11, 2023 (the "2023 Phase II") for an environmental investigation performed at 505 Grand Avenue, Little Chute, Wisconsin (the "Property). The Phase II was performed by Cedar Corporation on behalf of Todd Fischer, a prospective purchaser. The DNR understands a copy of the 2023 Phase II has been shared with you.

The 2023 Phase II reports that sub-slab vapors were investigated at two locations and found the following contaminants above the respective vapor risk screening levels (VRSLs). Note that DNR applies the residential VRSLs to mixed-use buildings that include a residential use.

The PCE in the sub-surface is likely attributed to the discharge from the historical dry cleaner at 513 Grand Avenue, Sandies Dry Cleaners & Laundry (Former), BRRTS #02-45-552222 (the "Site"). PCE breaks down in the environment to TCE, cis-1,2-DCE and vinyl chloride, which were also detected above their respective VRSLs. These concentrations indicate a risk for vapor intrusion and potential for these compounds to be present in indoor air above vapor action levels. Due to the health risk associated with vapor intrusion, the DNR recommends contracting with an environmental consultant to collect indoor air samples as soon as possible to assess whether there is on-going exposure to the contaminants. Please note the DNR has no authority regarding occupancy. The Village of Little

As stated in the September 27, 2023 letter to you regarding the vapor abatement system and Site update (the "September 27, 2023 Abatement/Site Update Letter"), additional investigation and cleanup of the Site may take place as local, state and/or federal funding becomes available; however, the time frame for this potential assistance is unknown. Additional information on vapor intrusion, risk associated with TCE and how to find a qualified mitigator experienced with vapor intrusion is included in the September 27, 2023 Abatement/Site Update Letter.
