Rob,

I am still trying to contact the owner of 125 Dousman St. I will be sending out a certified letter next week if I cannot get in contact by phone.

Regarding the PFAS sampling, the department is requiring one additional round of GW sampling to confirm the degree and extent of PFAS compounds. This should include all wells where the combined concentration of PFOS & PFAS was detected near or above 20 ppt and one downgradient well to confirm the downgradient extent. Because this is a VPLE site, the State cannot take on the PFAS liability given the single round of sampling data. If the Redevelopment Authority decides that they want the Certificate of Completion to include PFAS, we need the additional round of sampling. The department can then review the new information and determine if that data is sufficient.
