Dear Jason,

On August 17, 2008 at approximately 7:30 am, Oshkosh Corporation reported a release of diesel fuel to the DNR 24-hour Spill Hotline. The fuel was released on a gravel portion of the South Plant yard located at 333 W. 29th Ave, Oshkosh WI, 54902 due to an equipment malfunction. The spill was completely contained within the property, in an area approximately 20 feet by 20 feet. At that time, approximately five gallons of free liquid was recovered using absorbent materials.

On August 18, 2008, the impacted soil/gravel was excavated by an outside contractor to a depth of approximately 15 inches, into hard pack clay and loaded into containers supplied by Veolia Environmental Services. The area was excavated until no visual or olfactory evidence of fuel remained and was backfilled with clean gravel. Approximately 30 yards of soil, totaling 21.17 tons in weight was bio-piled at Veolia Environmental Services Glacier Ridge Landfill Facility. The certificate of disposal from the Glacier Ridge Landfill Facility is attached.
