Barber:

Based on the significant soil contamination in the source area (PCE up to 320,000 ppb and TCE up to 3,970 ppb), the presence of groundwater contamination beneath the source area at concentrations exceeding 4,000ppb PCE and 180 ppb TCE, previous sub-slab sample results, and lack of remedial action, the DNR recommends that the VMS is effective under the entire building/strip mall. If you would like to limit the VMS to certain areas then you would need to provide justification for this and likely you would need additional sub-slab sampling. The majority of the existing sub-slab samples have QA/QC concerns due to the presence of significant quantities of isopropyl alcohol in the samples.

You are reminded that due to VRSL exceedances, a remedial action to reduce the mass and concentration of the source is required prior to closure in accordance with Wis. Admin. Code NR 726.05(8).

Dear Mr. Amungwafor,

Per your requests dated November 8, 2021, HydroDynamics Consultants, Inc. has completed additional air sampling at Westwood Cleaners to identify potential indoor air and sub-slab soil vapor issues. Please find the attached a report for the site investigation for your reviews.

The results of the site investigation indicated that all the VOC concentrations from those samples are below the US EPA's Vapor Intrusion Screening Levels (VISLs), and therefore, HDC believes that it is not necessary to install the subslab depressurization system (SSDS) since there is no exceedance of Contamination of Concerns (COCs, PCE & related by-products) in the soil vapor samples for commercial properties. As a result, HDC recommends that the WDNR grant an official letter to bring the site to closure for environmental concerns regarding the existing contamination.
