## Dear Bishop Daniels:

On December 11, 2008, Drake Consulting Group notified the Wisconsin Department of Natural Resources ("the Department") that a spill had occurred from an underground pipe during demolition of the Building #3 South Footing area. The chlorinated solvent (CVOC) discharge was in an area that had no previous indication of any underground piping in this area. Based on information submitted to the Wisconsin Department of Natural Resources (DNR), you are responsible for restoring the environment at the referenced site under Section 292, Wisconsin Statutes, known as the hazardous substances spills law.

Because of the ongoing redevelopment of the site and the continued site investigations with Drake Environmental Group, we are exempting you from the steps normally required for responsible parties, provided all responsibilities defined in the statutes and in administrative codes are followed. Please refer to the hazardous substances spill law, Section 292.11(3) Wisconsin Statutes; to Wisconsin Administrative Codes chapters NR 700 through NR 746, including NR 708; and to Wisconsin Administrative Code, chapter NR 140. Current risk classification for this site is "not applicable" and is under the jurisdiction of the Department.

## **Hazardous Material Storage**

The Department understands that an immediate action was taken at the discharge site resulting in the storage of nine roll off boxes of CVOC contaminated soil that is designated as failed TCLP hazardous waste for CVOCs. Storage of this material onsite is limited to 90-days per Section NR 718.05, Wisconsin Administrative Code. Responsible parties shall notify the Department **in writing** if contaminated soil is stored onsite for 90-days or more on- or offsite, within 3 business days after the ninetieth day. Please have your consultant file the necessary documentation by the end of this month to meet this requirement.
