On behalf of Connell Aluminum Properties, LLC (Connell), Natural Resource Technology, Inc. (NRT) is submitting this formal request for a TSCA Coordinated Approval in accordance with 40 CFR 761.77(c) for the PCB remediation activities at the former Wabash Alloys facility in Oak Creek, Wisconsin. Also, we are providing the information required under 40 CFR 761.77(a).

Based on the April 2, 2015 site visit and information provided at that time, both the Wisconsin Department of Natural Resources (WDNR) and USEPA provided concurrence with NRT's determination (on behalf of Connell) that the subject site would be considered a Type C site under the One Cleanup Program Memorandum of Agreement (MOA) dated November 2006 and WDNR PUB-RR-786, dated November 2014.

The EPA ID number that has been used and will continue to be used to track the facility is listed above. The cleanup would be led by the WDNR, in accordance with the MOA for a Type C site.
