## Dear Eric;

We have received and reviewed your letter dated October 16, 2020 regarding Beazer East, Inc.'s September 3, 2020 submittal. In our September 3<sup>rd</sup> submittal, we tried to diligently reply to the requests made in your August 3, 2020 letter, and we provided what we believed were detailed narrative explanations and graphics to support the interpretation of the data derived from the various investigations.

In your October 16, 2020 letter you state that our response entirely failed to properly address the issues identified in DNR's August 3, 2020 letter but offer no further insight or clarification as to what was improper or inadequate in our submittal.

Without further clarification and direction from the Department, we are struggling to understand how to proceed; exactly what may have been missing, what additional information DNR seeks from us, and what specific items DNR considers to be improper or inadequate. Therefore, Beazer respectfully requests that a conference call be scheduled amongst representatives of Beazer and you and your management to identify in more detail what DNR believes must be provided to address these issues.
