Hi Mike:

During our phone discussion yesterday (26May2021), you indicated that Beazer would like to request a 30-day extension regarding the referenced subject. I have the following two questions to help provide you with response:

1. Provide any explanation or basis as to why the additional 30 days are necessary.

We appreciate the departments consideration of our request. Since the submittal of the Revised Interim Action Work Plan on May 3, 2021, we have been diligently working on the revision of the Remedial Action Options Report (RAOR). The revision of the RAOR has require a significant level of effort. As requested by the department, additional remedial options and alternatives were developed and evaluated. The draft of the document was only able to be provided for client review this week. With the holiday weekend and vacation schedules, additional time is required to complete the review and revision of the document. We believe that the thirty day request will be sufficient to complete these tasks.

2. Will this extension delay any of the other items identified in DNR's last letter to Beazer (dated March 3, 2021)?

With the exception of adding a separate meeting to discuss the Revised RAOR (mostly likely in late July) in addition to the meeting to be scheduled in late June to now only discuss the Revised Interim Action Work Plan, we do not, at this time, believe that there is a need to extend other items.
