Dear Mr. Bollinger:

On November 19, 2021, Beazer East, Inc. (“Beazer”) submitted an Interim Action Work Plan (“IAWP”) for the Former Koppers Tar Plant and Wabash Alloys Site (“Site”) to the Wisconsin Department of Natural Resources (“Department”) for review. Beazer requested technical assistance from the Department and submitted a review fee on December 16, 2021 in accordance with Wis. Admin. Code ch. NR 749. The Department provided to Beazer its review of the IAWP by letter dated January 21, 2022 (“January 21 Letter”). On January 27, 2022, the Department received a petition for a contested case hearing to review the actions of the Department in issuing the January 21 Letter (“Petition”).

The Department is reconsidering the January 21 Letter in response to the Petition and hereby rescinds the January 21 Letter. The January 21 Letter, in part, directs Beazer to include certain interim remedial actions at the Site. The Department is reconsidering its review of the IAWP and will reissue a letter in accordance with Wis. Admin. Code § NR 722.15 (2) and Wis. Admin. Code ch. NR 749. The Department is also considering whether to order Beazer to take any action in accordance with the provisions of Wis. Stat. ss. 292.11(7)(c) and 292.93, and Wis. Admin. Code § NR 728.09, which authorize the Department to issue administrative orders to responsible parties.
