Good evening Steve,

I am sorry if the tone of this email is any way terse because I am very frustrated with your response because you give us no new information. I was also asking what documentation YOU have, because Dave Larsen won't give us any of the information. So perhaps you can empathize with my frustration that your letter basically says "I don't know, Dave Larsen says maybe, but won't give us proof either."

What you are saying, and please correct me if I am wrong, you have NO IDEA what activity has occurred on this project since the closure letter from 2017. No documentation of anything.

When I look at the BRRTS website, which I admit I am new at, it shows the closure memo was dated 05/23/2017.

Since that time, if I am reading it correctly, there has been \$10,187.70 paid out to REI, and if what you're telling me is correct, the state of Wisconsin has NO IDEA what ANY of that money was paid out for? How can that be? You also have NO RECORD of ANY sample results that were supposed to have been taken? How can that be?

I am looking at an email from Gina Keenan to Dave Larsen dated 07/21/2017 on BRRTS (a copy is attached) where she talks about a sample schedule and giving enough time to abandon, etc.

I am also seeing an email from Dave Larsen to Gina dated 05/04/2018 with a quote to abandon the wells for \$1,835.70 (attached), which was apparently approved. Are you saying the DNR paid that money but didn't receive actual confirmation the wells were actually abandoned? If not, what happened to the money? Why is the state not alarmed by this or holding REI accountable?

If what you are saying is correct, I suspect that REI may be committing or has committed some sort of fraud here, and if that is the case, this matter needs to be escalated immediately. Would you please get your supervisor involved and have them contact me? I will be in the office and available tomorrow anytime from 10 to 3 pm.

Dave,

I was going over the U&C, and was wondering if you could modify the submittal to include the following:

- -costs for abandonment of PW-1 and PW-2.
- -groundwater sampling for the temporary wells -2 samples total for PVOCs & 1,2 DCA
- -only one of round of groundwater samples for the 2 potable wells
- 4 rounds of bi-annual groundwater sampling of MW1, MW2, MW3 and MW6 (16 samples total). I know we had a discussion as to timing with regards to the sunset of PECFA on this issue, but based on my calculations, I don't see any issues if the wells are sampled on the following schedule: 8/17, 3/18, 3/18 and then 3/19. That will give enough time for closure, abandonment of wells, submittal of invoices, etc. This schedule could potential be shortened up also, depending on sample results.

I would have modified the U&C if it was for changes to the groundwater sampling only. However, the abandonment of the potable wells made it too complicated.
