Tim Panzer, being first duly sworn, on oath deposes and says:

- 1. That he is an employee of the Wisconsin Department of Natural Resources and has personal knowledge of the accuracy of the facts set forth in this notice.
2. That this notice of lien is being recorded for the purpose of perfecting a lien on the above-described property under section 292.81, Wisconsin Statutes. The property remains subject to this lien until this lien is satisfied. This lien is superior to all other liens that are or have been filed against the property, except that if the property is residential property, as defined in s. 895.52 (1) (i), Wis. Stats., the lien does not affect any valid prior lien, as defined in s. 292.81 (1), Wis. Stats., on that residential property.
3. The Wisconsin Department of Natural Resources has incurred expenses totaling \$95,500 to investigate contaminated soil and groundwater on the Mann Engineering LTD Employee Trust Fund property (aka Mankowski property), located on 26th Ave. at 45th-48th St, Kenosha, Wisconsin.
4. The Department certifies that to the best of its knowledge and belief, all information contained in this Lien is correct, and this lien represents a legal encumbrance upon the property. Based on the above information and the authority of s. 292.81 (3), Wis. Stats., the Department claims a lien against the interest which the owners have in the above-described property in the amount of \$95,500.

 In accordance with s. 292.81(4) Wis. Stats., notice is hereby given that the Department of Natural Resources ("Department") intends to file a lien against the Mann Engineering LTD Employee Trust Fund's property (aka Mankowski property) located on 26th Ave. at 48th & 49th St. Kenosha, Wisconsin in order to recover costs incurred by the Department related to investigation of contaminated soil and groundwater conducted in accordance with s. 292.11 Stats.

The property subject to this lien is identified in the County's property data base as Parcel Number 09-222-36-134-003. It is adjacent to the Kenosha Palm Elementary school and is the location of the former Chrysler Building 556.

As of the date of this notice we estimate that the Department has incurred costs totaling \$95,500. The Department anticipates incurring additional costs for the completion of cleanup activities at the site. The amount of the lien will be \$95,500.

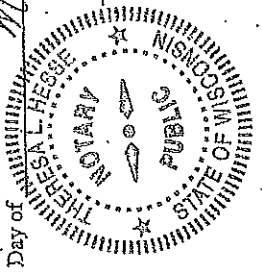
