Jagemann Plating Company is moving forward with the installation of a vapor mitigation system at their facility. Communication testing was completed on September 30, 2015. The vapor mitigation system is currently being designed and should be installed at the site in the very near future. Once the system has been installed and has been allowed to run for a sufficient amount of time to come to equilibrium, additional indoor air sampling will be performed.
