Hi Tauren:

Sorry I am a bit late on that work scope. I have it nearly completed. I have to modify the original scope a bit after talking with Mike Jagemann. We went ahead and proceeded with some work plan items such as passive soil gas sampling and sub-slab sampling to better determine the extents of vapor impacts. We also performed a quarterly post-remedial groundwater monitoring event and have sampled six outlier wells for PFAS to see if the PFAS has potentially migrated off-site. I will be returning to the site next week to retrieve the passive samplers and measure explosive gases in select wells and sub-slab vapor ports. It will be a while before the soil gas and PFAS results come in, probably mid to late November.

In the meantime, I will complete the work scope and get that to you by the end of next week, November 3<sup>rd</sup>.
