

- **Liability for cleanup doesn't end when the program expires.** The responsible party's obligation to address environmental contamination associated their site continues whether PECFA reimbursement funding is available or not. Therefore, the DNR highly encourages responsible parties to complete PECFA-eligible cleanup work as soon as possible.
- **Reaching the finish line.** By now, all PECFA-eligible sites should have an approved remedial action plan in place and be actively implementing remedial action (if not already complete.) Eight rounds of quarterly groundwater monitoring are required unless otherwise directed for case closure. Currently there are only eight quarters left remaining in the PECFA program.


