On August 06, 2019, the Wisconsin Department of Natural Resources (Department) received a scope of work (SOW) and cost estimate utilizing the chapter NR 747, Wisconsin Administrative Code, Usual and Customary Cost Schedule (Cost Schedule) for the site referenced above.

The Department has determined that the submitted SOW is reasonable and **approves** the additional costs. This site will be deferred from the public bidding process at this time. The Department will contact you if this site will be bid in the future.

This approval is for the installation of (2) monitoring wells and (1) piezometer to define degree & extent. (1) round of groundwater sampling (PVOC + Naphthalene) from all wells + (2) private wells (8035 and 8031 Hwys 32 & 45). Sample (2) PWs at the Clear Lake Club (VOCs Method 524.2), waste disposal and a letter report upon completion. A copy of the Department worksheet for the Cost Schedule tasks is enclosed for your reference.

These activities will be reimbursed according to the task specifications and with submittal of proper supporting documentation at claim review time.



The Department approves a variance from the Cost Schedule for well evaluation at the Clear Lake Club by the consultant. The Department waives the commodity three-bid requirement with this variance approval.

Final determination regarding the eligibility of costs will be made by the claim reviewer when the entire claim, including all invoices and reports, is submitted for payment.
