Hi Pat:

We have completed the review of your Site Investigation Report and Remedial Action Documentation Report (SIRADR), received on June 29, 2018. The Site Investigation Report (SIR) and monitoring well information were requested to complete the administrative review of the subject site. The SIR was included as part of the SIRADR.

The subject site (222 North Chicago Avenue), originally included the parcels (in South Milwaukee, WI) as follows:

- 211 11th Avenue;
- 1010 Davis Avenue;
- 200 North Chicago Avenue;
- 208 North Chicago Avenue; and,
- 212 North Chicago Avenue.

Each of the parcels had its own historical use. The DNR understands that the subject site operated as manufacturing; commercial and/or retail facility. Fill materials were also identified at the site. The primary contaminants are VOCs, PAHs, and metals. The subject site has been redeveloped into a commercial/retail outlet. Based on the review of the SIRADR, and to meet the requirements of SIR in compliance with Ch. NR 716 Wis. Adm. Code, we request a discussion of sources of discharge and how the sources of discharge relate to the site investigation as follows:

- Relate the contaminants to the source parcel;
- Define the degree and extent of the contamination;
- Post data on the map and provide iso-contours;
- Evaluate environmental media affected
