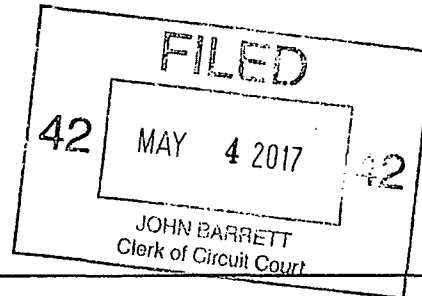

STIPULATION AND SECOND ORDER AMENDING JUDGMENT

IT IS STIPULATED AND AGREED by Plaintiff State of Wisconsin and Defendant Bishop's Creek Community Development Corporation that the Stipulation and Order for Judgment signed and filed on August 10, 2016 and the Order Amending Judgment signed and filed on November 29, 2016 shall be amended as follows:

1. Defendant shall complete the duties enumerated in paragraph 7 of the August 10, 2016 Stipulation and Order for Judgment by October 31, 2017. Paragraph b. on page 2 of the November 29, 2016 Order Amending Judgment is therefore amended to include October 31, 2017 as the previously unidentified completion date.

2. Defendant has identified Kevin Bugel with the consulting firm Giles Engineering to perform the duties identified in paragraph 7 of the August 10, 2016 Stipulation and Order for Judgment. The notice condition in paragraph a. on page 2 of the November 29, 2016 Order Amending Judgment has therefore been satisfied, eliminating the need to provide a specific performance date in that paragraph of the


November 29th Order.

3. The Second Order Amending Judgment accompanying this Stipulation may be entered incorporating the terms of this Stipulation without further notice, and may be docketed, pursuant to Wis. Stat. § 806.10(1).

4. The Second Order Amending Judgment accompanying this Stipulation will be a final and appealable Order. However, the stipulating parties hereby waive their right to appeal that Order.




IT IS THEREFORE ORDERED that the Order Amending Judgment signed and filed on November 29, 2016 is hereby AMENDED to require Defendant to:




The Order Amending Judgment signed and filed on November 29, 2016 is hereby AMENDED to require Defendant to:
