## Dear Mr. Beaster:

The Department of Natural Resources (DNR) considers the Enbridge Energy – Tank 12 site closed, with continuing obligations. No further investigation or remediation is required at this time. However, you and future property owners must comply with the continuing obligations as explained in the conditions of closure in this letter. Please read over this letter closely to ensure that you comply with all conditions and other on-going requirements. Provide this letter to anyone who purchases this property from you.

This final closure decision is based on the correspondence and data provided, and is issued under ch. NR 726, Wisconsin Administrative Code. The DNR Northern Region (NOR) Closure Committee reviewed the request for closure on December 3, 2012. This environmental remediation case was reviewed for compliance with state laws and standards.

The site began as a spill of 40 gallons of crude oil released by a leaking valve adjacent to the tank 12 berm. The spill response and clean up included product recover and excavation of the petroleumimpacted soil. Confirmation sampling was done to confirm the degree and extent of contamination. The conditions of closure and continuing obligations required were based on the property being used for industrial purposes.

## Continuing Obligations

The continuing obligations for this site are summarized below. Further details on actions required are found in the section <u>Closure Conditions</u>.

• Residual soil contamination exists that must be properly managed should it be excavated or removed.

## GIS Registry

This site will be listed on the Remediation and Redevelopment Program's internet accessible Geographic Information System (GIS) Registry, to provide notice of residual contamination and of any



continuing obligations. DNR approval prior to well construction or reconstruction is required for all sites shown on the GIS Registry, in accordance with s. NR 812.09(4) (w), Wis. Adm. Code. <u>Residual Soil Contamination (ch. NR 718, or ch. 289, Stats.; chs. 500 to 536, Wis. Adm. Code)</u> Soil contamination remains in the vicinity of sample locations B-4, S-7, and S-8, as indicated on the attached map (Figure 3 – Site Detail Map). If soil in the specific locations described above is excavated in the future, the property owner at the time of excavation must sample and analyze the excavated soil to determine if contamination remains. If sampling confirms that contamination is present, the property owner at the time of excavation will need to determine whether the material is considered solid or hazardous waste and ensure that any storage, treatment or disposal is in compliance with applicable standards and rules. In addition, all current and future owners and occupants of the property need to be aware that excavation of the contaminated soil may pose an inhalation or other direct contact hazard and as a result special precautions may need to be taken to prevent a direct contact health threat to humans.

Please send written notifications in accordance with the above requirements to me at the Superior office. Please be aware that the case may be reopened pursuant to s. NR 726.09, Wis. Adm. Code, if additional information regarding site conditions indicates that contamination on or from the site poses a threat to public health, safety, or welfare or to the environment.









