Kurt,

I understand your reluctance to put two additional monitoring wells on your property. You feel you may be jeopardizing your development opportunity if you agreed to the wells. It is your right to refuse access, but there is a downside. The way the spills law is written, the responsible party is the one who caused the release <u>OR</u> the one who possesses and controls the release. By denying access to investigate and/or remediate this release on your property, you will be taking control of that portion of the contamination on your property and you would in turn be responsible for it. This approach has been upheld by the court system. I have attached a link to the DNR web-site that addresses off-site contamination.

I think if we sit down and discuss our objectives and expectations, we can come up with a plan to help all parties. For instance, we can use temporary wells that could be quickly removed if they became an issue in your redevelopment. I am confident that the information we will gather will be more helpful to your redevelopment project than denying access.
