This investigation has been required by the Wisconsin Department of Natural Resources (WDNR) to comply with the requirements of Wisconsin State Statute 292.11. Through previous investigative work at the Site, it has been determined that that dry cleaner-related soil impacts are present beneath the building on the property. The WDNR is requiring the air (atmosphere) be sampled within the Site building to determine if the impacted soil beneath the building is affecting the indoor air quality.

The property/building owner has granted REL permission to complete the required air sampling. REL is requesting your cooperation in accessing the space you occupy within the Site's building to complete a building/occupant survey and potentially sample the air within your space. The building/occupant survey is a gathering of information about the activities taking place within the building, the building construction, building layout, HVAC system information, inventory of chemical use and storage, and the presence of a basement, etc. The building survey of your space may be completed in approximately 30 minutes. The information gathered during our survey will determine the actual locations for the air sampling within the Site building.
