Good evening, Gwen –

Chad nor myself has received the BRRTS semiannual submittal request, so per our telephone conversation earlier today, I have included a brief discussion on the work that was completed during the first half of 2021:

During the 1<sup>st</sup> half of 2021, another round of groundwater sampling was conducted and the Additional Site Investigation Report was finalized on March 19, 2021 and submitted to WI DNR for a formal review and response. Comments were received on May 19, 2021. Authorization for addressing the comments was received at the end of June 2021 and will begin with an additional round of groundwater set to be collected during the second week of August 2021. The authorization also includes the preparation of a Vapor Intrusion (VI) Work Plan, documenting attempts to drill an off-site piezometer, and expanding the additional site investigation to include intermediate-depth piezometers. Progress on the VI Work Plan, additional sampling results, and attempts to access an off-site location will be provided to the WI DNR Project Manager.
