Dear Ms. Vang:

On behalf of Don Smith Sales, Seymour is submitting this budget request for additional work at the subject property. The requested budget is for the costs to prepare the closure packet required by WDNR. The total requested budget is \$4826.41.

The budget request includes several items related to the preparation of the closure request. These include the cost for the preparation of the primary closure form and attachments, cost for continuing obligation for residual contamination within the public right-of-way adjacent to the source property, and engineering review fees. Based on the data collected, the source property will have a notification for residual soil contamination within the adjacent right-of-way. The residual soil contamination in the ROW primarily contains PAHs at levels exceeding direct contact RCLs. Because of this, we do not believe any special considerations will be needed to address utility corridor migration.

Attached please find a cost estimate we have prepared using the U&C Cost Schedule #27 for this work. Upon receipt of your approval, Seymour will begin the work. If you have any questions about the site please feel free to give Mark Fryman or me a call (608-838-9120) anytime.
