Jon,

As we discussed by phone, I wanted to clarify that the only MRSs to which LUCs in the form of continuing obligations (COs) under Section 292.12 of the Wisconsin Statutes will apply are those on the DNR database, specifically SR503, SR503c, SR504, and SR506. FR501 was formally given a designation of “No Action Required” on the state database on 2/28/2017 (**therefore, WI COs will not be applied there**), and no notification of any hazardous substance release was ever received by DNR for MU507.

In addition, it should be noted that restrictions on “groundwater use” under WI COs will not consist of strict well prohibitions; rather, DNR approval prior to well construction or reconstruction will be required, in accordance with s. NR 812.09 (4) (w), Wis. Adm. Code. This requirement will apply to private drinking water wells and high capacity wells. At the time of formal site closure, if any of the inaccessible areas of certain MRSs are determined to have presented an impediment to a complete site investigation and/or cleanup of MC, WI COs may also include requirements for additional environmental work if and when those areas ever become accessible.

For each MRS, the final site closure letter will be the enforceable document by which WI COs are imposed. These letters will be issued after a formal case closure request form is submitted for each MRS, together with applicable review fees. Please let me know, if you have specific questions regarding that process or anything else stated above.

Thank you for the opportunity to comment on the Proposed Plan.
