This release will need to be added to the GIS Registry submittal for the facility wide ERP site once the MOAs are completed and this site is transferred to the Facility Wide ERP site.

We have a spill recorded at Tank 1 that occurred on Jan 1, 2006. The BRRTS number for the closed 2006 spill is 04-16-548608. All the closed spill files are in Rhinelander so I do not have much information on the 2006 spill. Could this contamination be residual contamination from that spill?
