I had submitted a Notification of Hazardous Substance Discharge in November 2022 because PCBs were identified on a single soil sample, but it was determined by the WI DNR that the result was most likely due to sampling or laboratory error. Also, that Notification of Hazardous Substance Discharge that I had submitted is not listed in the documents section on webpage for the Medical Center's BRRTS site most likely due to it being determined that PCBs are not a substance of concern at the Medical Center.

Could you please clarify whether or not that is a substance of concern for the Medical Facility? If not, is it possible to have it removed from the substances list on the BRRTS webpage?

Hi Greg,

Please find attached a Historical Fill Exemption Request and Notification for Hazardous Substance Discharge, for your reference. I am reaching out to you directly to make you aware that PCB-1260 in soil was found which is greater than NR 720 groundwater protection RCL. Also, several PAHs were detected in groundwater over NR 140 Enforcement Standards and several metals over NR 140 Preventative Action Limits.

Backstory is that the Milwaukee Metropolitan Sewerage District (MMSD) is constructing a new metropolitan interceptor sewer (MIS) through VA Property. Due to concerns from the Environmental Site Assessment, a Material Characterization Report was performed which uncovered the PCB-1260 and PAHs and Metals in the groundwater.

Please let me know if you have any questions or concerns. I would appreciate you providing any guidance on how this will impact our BRRTS site and any action that we need to take.
