Dear Ms. DiMaggio:

I am requesting budget for additional activities at the Richard Rath property in Cuba City, Wisconsin. The requested items are related to obtaining site closure. Activities in the request include: preparation of a closure request packet, and monitoring well abandonment costs.

Costs related to site closure packet submittal include closure request preparation, GIS for the residual soil contamination at the source property, and engineering review fees.

Costs related to monitoring well abandonment included consultant coordination, and driller mobilization and abandonment charges. Additionally, a regulatory correspondence is included for submittal of the abandonment forms and documentation of the disposal of the investigative wastes that are present at the site.

Because of the PECFA timing constraints, we would like to abandon the monitoring wells prior to obtaining the site closure if possible. Since no significant groundwater contamination has been identified at the site we believe a variance to conduct the abandonment in this manner is not unreasonable.

We are requesting an additional \$6294.34 to conduct the activities described above. The costs are included on the attached U&C standardized invoice. Please feel free to call Mark Fryman or me at 838-9120.
