Good afternoon.

Adam Streiffer – Dept. of Health Services determined, based on the demographics of the tenants occupying the apartment complex at 109 Steele Street, that immediate indoor air sampling was needed to assess potential risk. DHS had the state lab deploy two indoor air Summa canisters to me at DNR to collect two indoor air samples at the apartment complex. DHS does get some funding that can be used each year for these type of immediate scenarios, but this is not done in many situations. I will be sampling tomorrow morning when I meet with the property manager and going back Friday to pick up the 24 hour sample Summa canisters to be sent in for laboratory analysis.

This is only to assess immediate risks and does not change your current timelines or requirements previously discussed in regard to the vapor mitigation on the source property and sub-slab with concurrent indoor air sampling for the apartment complex. I will follow up on this when I have received the indoor air results from the state lab.
