Hello Tauren - Now that we have vapors under control in our building and have renters in the lower apartment, I'd like to start discussing next steps with the investigation. Chris & I talked about having a meeting with you sometime this summer, so let's start planning for that. Right now I'd prefer to meet mid-to-late August, or September.

Unfortunately Harmon & Vy have deteriorated significantly since our last meeting so it will be difficult to include them in the discussion. I think you're aware that we moved them to Woodside assisted living here in Green Bay about 18 months ago. Both of them now have advanced dementia and just last week Harmon experienced a debilitating fall. He can't walk, has lost use of his hands, and his thought process is very poor. He's in rehab for an indefinite period & may end up in the nursing home at Woodside, depending on how much he recovers. We have started the process of invoking Ann as durable POA.

Just wanted to touch base with you to keep moving the process moving forward.
