Thanks for the reminder, Derrick. Regarding the current site status, the site investigation activities are continuing at this site. The DNR and the Seidensticker's environmental consultant, Konicek, have been trying to get access from the City of West Bend to install a monitoring well in the right-of-way. This well is needed to define the degree and extent of groundwater contamination associated with the hazardous substance discharge from the former dry cleaning operations that occurred at 910 S. Main Street. The DNR has a public database where you can review the file documents (here) associated with this environmental contamination case referenced by BRRTS # 02-67-576350. You'll see that the DNR sent an email to the City on January 24, 2024. Currently, the DNR is waiting for a response to this email. Note that the site investigation is an iterative process and more investigation may be needed depending on the findings.
