Per your email dated March 17, 2020, you provided some considerations to address the vapor pathway at the site. One of the considerations offered was to collect vapor samples at the day-care facility directly south of the site per the screening criteria contained in RR-800. Given the use of the property as a day-care facility and the contaminants of concern, an assessment of the potential for

vapor intrusion at the day-care would be beneficial.

Based on this recommendation, we reached out to the owner's of the day-care facility (Kindercare) to request access to the facility to install a sub-slab vapor point to allow for the collection of a sub-slab vapor sample for analysis. We were informed, due to the current COVID-19 pandemic, Kindercare is not allowing access to any of their day-care facilities by outside contractors. As such, it is not possible to collect a sub-slab vapor sample from beneath the Kindercare day-care facility. Additionally, the northern portion of the Kindercare property located between the Krystal Cleaners location and the Kindercare building is occupied by a playground area for the children; therefore, it is not possible to install soil vapor probes within approximately 70 feet of the north face of the Kindercare building.

As the COVID pandemic does not appear to be subsiding anytime soon, it is our assumption that access to the Kindercare facility will be limited for an extended period of time. Therefore, we are requesting the WDNR provide evaluation options suitable to the WDNR that could be used in this specific scenario to evaluate the potential for vapor intrusion at the Kindercare facility.
