At that time I will close the spill and reference the contamination was suspected to be from the 2003 spills and add a note to the BRRTS tracking for the closed 2003 spill (BRRTS #02-16-513788) that new information was received. That way there is a record that Enbridge reported the newly found contamination to the Department.



20150121NO16-1: crews continue to chip away the frozen soil and remove all pieces with a vac truck. Work will likely continue at this locations for a few days since product is located under catwalks, piping, etc., and will prove to be difficult to access. Barr will continue to be onsite to monitor progress.

20150113NO16-1: All visible product has been cleaned up. Barr is currently field screening base and side walls to determine the extent of contamination. While it seems like we are now digging in a historical contamination from a few previous leaks, crews will continue to excavate the high PID readings.
