Good morning David,

I received the paper copy of the revised work plan on March 17, 2017. This email acts as my notice to proceed with the work plan with the following revisions/comments:

- Due to the elevated lead above the background threshold value (BTV) and groundwater pathway residual contaminant level (RCL) at the Stockpile-01 location, which corresponds to the VAS-10 location, groundwater should also be sampled for dissolved RCRA metals at VAS-10.
- If significant contamination is found at any of the locations, do you plan to utilize the temporary monitoring wells for follow up sampling?
