Hope you are well.

We have made progress on several fronts.

- The eighth quarterly groundwater sampling event was completed in March. We received the lab data and are preparing a report that summarizes all eight rounds. It includes a statistical trend analysis and an evaluation of the MNA parameters run on the last round.
- The vapor and soil sampling work plan has been updated to incorporate the last set of comments that were included in the February 4, 2020 approval e-mail.
- Last week, we obtained a signed access agreement from the owner of the 1303 19th Street property and are making preparations to proceed with sub-surface utility clearance prior to an initial round of sub-slab vapor sampling.
- Now that the shelter at home order has been lifted, we are preparing to perform the field work, including sewer vapor sampling, hand auger soil sampling, and sub-slab vapor sampling.
